 - Penny Diebel, College of Agricultural Sciences Assistant Dean for Academic Programs, will be present
 - The College of Business associate deans have been invited to meet with the Curriculum Council but, at the time the agenda was prepared, no response had been received.
 - <u>Response</u> to COB Concerns from Jonathan Valez NOTE: This response is now in the online proposal, but was not when the course was reviewed last week.
 - May 17 recap -
 - The proposal is to change the course description and extend this existing course to the broader campus as a Baccalaureate Core course in the Social Processes and Institutions category.
 - The COB liaison comments for this course from Prem Mathew were not supportive. He noted that a number of COB faculty have research expertise, are well-published in the organizational leadership domain and there are a number of related business courses. Additionally, there appears to be no content specific to programs in CAS.
 - During the Curriculum Council meeting, the COB representative indicated that there is significant overlap with an existing COB course, and the titles are very similar. There are also concerns related to redundancy in the curriculum.
 - Additional discussion included:
 - CAS has had the leadership program for quite a while.
 - The current instructor advised a Council member that there is demand since it is being taught to 99 students from all over campus.
 - The COB could have offered their similar course as a Baccalaureate Core course, as CAS is attempting to do.
 - The understanding is that the CAS leadership program is not entrepreneurial, so one felt the course was very different from the COB course.
 - Issues related to COB accreditation.
 - From a student point of view, having similar course titles is problematic.
