

# **Decreased levels of State Appropriation**




Loss of nearly \$6 million of annual support per year

#### UNIVERSITY FUNDING SUMMARY AND HISTORY

Public University funding primarily flows through the following five channels:

1. Public University Support Fund (PUSF): The PUSF is the state's primary direct funding contribution for university operations and is allocated to institutions via the Student Success and Completion Model (SSCM).

**NOTE**: A designated PUSF was first created in the 2013-15 biennium. Prior to 2013-15, a number of different individual appropriations comprised what would today be recognized as the PUSF. Because of this historical incongruence, PUSF figures prior to 2013-15 reported in this document represent efforts to unpack sections of historical appropriations and repack them into groups that approximate today's appropriation categories, including the PUSF.


# Development of the 10-Year Strategic Capital Plan for Oregon Public Universities

The Higher Education Coordinating Commission recently completed a10-year strategic capital plan for public universities, in partnership with the public universities and an external expert in educational strategic capital planning. This project has provided a target public university capital portfolio through 2029 and will be used to guide Commission in prioritization of capital projects and recommendations to the Governor and the Legislature on the critically important need for strategically driven capital investments for years to come.



- 1. Achieving the 40% goal of baccalaureate and above in the 40-40-20 plan is not dependent on significant capital investment in new physical facilities, but investment in capital renewal may accelerate progress toward that goal by addressing deficiencies in existing facilities;
- 2. Enrollment history and future demographics do not forecast statewide capacity issues;
- 3. There are statewide occupational needs in Health and STEM-related fields;
- 4. Utilization analysis and space needs assessments also indicate some room for growth, though specific program areas may need localized attention.








Overall, the space needs assessment showed that in the Fall 2018 term the eight campuses collectively had a 9% surplus of academic and academic support space, as indicated in the following chart. Individually, there is generally a surplus of academic space and a deficit of academic support space, highlighting that while the campus may have enough space, it may need to be repurposed or reconfigured to more effectively achieve student success.






#### PROJECTING ENROLLMENT DEMAND

■ The rate at which recent high school graduates in Oregon elect to attend college anywhere in the US within 12 months of high school graduation is among the lowest in the country, while the participation rate among adult learners exceeds the national average.
