# **Executive Summary**

This proposal would terminate the Russian Studies Certificate, which can no longer be earned by students at OSU because the required coursework has not been offered for over 5 years and cannot be offered with existing resources. This is a direct effect of the administrative decision not to hire new faculty into two tenure lines left vacant by retirement in the past decade.

The Russian Studies certificate was OSU's highest credential in Russian language and culture with faculty FTE allocated primarily to undergraduate teaching with lesser commitments to scholarship and service.

# D. Resources needed, if any: personnel, FTE academic, FTE classified, facilities, and equipment.

The Russian Studies certificate was delivered by two full-time tenured faculty.

# E. Funding sources: state sources (institutional funds- state general fund, tuition and fees, indirect cost recoveries), federal funds, other funds as specified.

The Russian Studies program was funded entirely through E&G allocations.

# F. Relationship of the proposed unit to the institutional mission.

Russian studies continues to be relevant to the mission of Oregon State University in that it provides opportunities for engagement with one of the largest non-English speaking communities in the state of Oregon as well as Russian speakers living in Russia and former Soviet nations.

There are currently no long-range plans for Russian Studies at Oregon State University given the lack of support from administration to maintain necessary resources.

The OSU Russian Studies program maintained relationships with Russian programs at PSU and the flagship Russian program at the UO. These two schools continue to offer majors and minors in Russian.
